

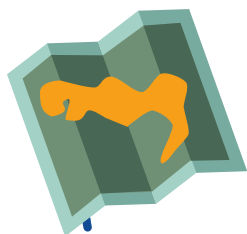

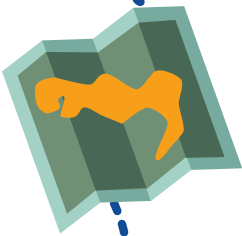

DWC does NOT pay medical bills; the insurance companies process medical bills.

Health care providers must call the insurance company for medical bill status.

If you are not a party to the workers' compensation claim, you may not receive confidential claim information.
