**CONSENT ORDER**

**RESTORATION OF PRIVILEGES**

**General remarks and official action taken:**

On this date came on for consideration by the Commissioner of Workers' Compensation, the application submitted by Alejandro Lopez, M.D. (Dr. Lopez) requesting restoration of his privilege to provide health care services under the Texas Workers' Compensation Act (Act) and rules adopted thereunder and to receive remuneration under the Act and rules adopted thereunder.

Staff of the Texas Department of Insurance, Division of Workers' Compensation (TDI-DWC) and Dr. Lopez announce that they have compromised and settled this matter and agree to the entry of this Consent Order. The parties request that the Commissioner of Workers' Compensation dispose of this matter pursuant to TEX. LAB. CODE ANN. §402.00128(b)(7) and § 408.0231, and 28 TEX. ADMIN. CODE Chapter 180.

**JURISDICTION**

The Commissioner of Workers' Compensation has jurisdiction over this matter pursuant to TEX. LAB. CODE ANN. §§ 402.001, 402.00111, 402.00116, 402.00128, 408.023, and 408.0231, and 28 TEX. ADMIN. CODE Chapter 180.

**WAIVER**

Dr. Lopez acknowledges the existence of certain rights provided by the Texas Labor Code and other applicable laws and rules to which he may be entitled, including the right to a hearing and a public meeting under 28 TEX. ADMIN. CODE § 180.27. Dr. Lopez

waives all of these rights, as well as any other procedural rights that might otherwise apply, in consideration of the entry of this Consent Order.

## FINDINGS OF FACT

The Commissioner of Workers' Compensation makes the following findings of fact:

1. Dr. Lopez is a medical doctor licensed in the State of Texas.
2. In Commissioner of Workers' Compensation Order No. DWC-10-0004 dated February 16, 2010, the Commissioner of Workers' Compensation ordered Dr. Lopez to withdraw from the Texas Workers' Compensation system and to cease and desist from performing or billing for services in the Texas Workers' Compensation system.
3. On July 12, 2010, the TDI-DWC received Dr. Lopez's written application for restoration of his privilege to provide health care services under the Act and rules adopted thereunder and to receive remuneration under the Act and rules adopted thereunder.
4. After applying for restoration of his privileges, Dr. Lopez and his staff voluntarily submitted to and successfully completed training by TDI-DWC staff on requirements under the Act and rules adopted thereunder that included requirements governing Reports of Medical Examinations (DWC-69) and Work Status Reports (DWC-73).
5. Dr. Lopez understands that he is subject to a TDI-DWC audit on his compliance after the entry of this order with requirements under the Act and rules adopted thereunder governing Reports of Medical Examinations (DWC-69) and Work Status Reports (DWC-73).
6. The Medical Advisor has reviewed Dr. Lopez's application and is of the opinion that he has all appropriate unrestricted licenses/certifications, has overcome the conditions that resulted in sanction, and should be restored of the privilege to provide health care services under the Act and rules adopted thereunder and to receive remuneration under the Act and rules adopted thereunder.
7. The Medical Advisor recommends that the Commissioner of Workers' Compensation restore Dr. Lopez's privilege to provide health care services under the Act and rules adopted thereunder and to receive remuneration under the Act and rules adopted thereunder.

## CONCLUSIONS OF LAW

Based upon the foregoing Findings of Fact, the Commissioner of Workers' Compensation makes the following conclusions of law:

1. The Commissioner of Workers' Compensation has jurisdiction over this matter pursuant to TEX. LAB. CODE ANN. §§ 402.001, 402.00111, 402.00116, 402.00128, 408.023, and 408.0231, and 28 TEX. ADMIN. CODE Chapter 180.
2. The Commissioner of Workers' Compensation has authority to dispose of this matter as set forth herein under TEX. LAB. CODE ANN. §402.00128(b)(7) and § 408.0231, and 28 TEX. ADMIN. CODE Chapter 180.
3. Dr. Lopez has knowingly and voluntarily waived all procedural rights to which he may have been entitled regarding the entry of this Order, including, but not limited to, the right to a hearing and a public meeting under 28 TEX. ADMIN. CODE § 180.27.
4. After evaluating Dr. Lopez's application, the Medical Advisor has determined that Dr. Lopez has all appropriate unrestricted licenses/certifications and has overcome the conditions that resulted in sanction. The Medical Advisor is of the opinion that Dr. Lopez should be restored of the privilege to provide health care services under the Act and rules adopted thereunder and to receive remuneration under the Act and rules adopted thereunder and recommends that the Commissioner of Workers' Compensation restore Dr. Lopez of such privileges.
5. The Commissioner of Workers' Compensation finds that Dr. Lopez has met all requirements under the Act and rules adopted thereunder for restoration of his privilege to provide health care services under the Act and rules adopted thereunder and to receive remuneration under the Act and rules adopted thereunder and should be restored of such privileges.

Based on the Findings of Fact and Conclusions of Law above, the Commissioner of Workers' Compensation has determined that the appropriate disposition is the issuance of the following order:

**IT IS THEREFORE ORDERED** that Dr. Lopez is restored of the privilege to provide health care services under the Act and rules adopted thereunder and to receive remuneration under the Act and rules adopted thereunder.

**IT IS FURTHER ORDERED** that Dr. Lopez shall submit to a TDI-DWC audit on his compliance after the entry of this order with requirements under the Act and rules adopted thereunder governing Reports of Medical Examinations (DWC-69) and Work Status Reports (DWC-73).



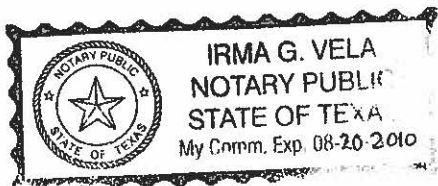
